

Code of Ethics and Conduct for Students

1. He/she shall be regular and must complete his/her studies in the College.
2. All students must uphold academic integrity, respect all persons and their rights and property and safety of others; etc.
3. He/she must produce the identity card, issued by the college.
4. He/she should not Parking a vehicle in a no parking zone or in area earmarked for parking other type of vehicles
5. He/she should be forbidden for Smoking on the campus of the college.
6. 12. All the students are informed that they should not involve in act of sexual misconduct or harassment which encompasses a range of conduct, including sexual assault, unwanted touching or persistent unwelcome comments, e-mails, or pictures of an insulting or degrading sexual nature etc.

13. Any student of the college aggrieved by any acts of sexual harassment or ragging can approach the Student Grievance Redressal cell at the college.

Code of Ethics and Conduct for the Faculty and Support Staff:

The teachers shall:

1. Always be punctual in attending to duties in the college.
2. Treat all students with respect and dignity and be just and impartial to all irrespective of caste, creed, sex, status, religion, language and place of birth;
3. Acknowledge and respect the uniqueness, individuality and specific needs of pupils/students and promote their holistic development
4. Refrain from accepting remuneration for coaching or tutoring his/her own students except for remedial teaching under an approved scheme;
5. Seek to establish and maintain cordial relations with parents/ guardians.
6. Work in a collaborative manner with students, guardians, management, and other members of staff, relevant professionals and the wider school community, as appropriate, in seeking to effectively meet the needs of students.
7. Faculty should exhibit intellectual honesty and integrity in all their scholarly endeavors.
8. Faculty should refrain from lodging unsubstantiated allegations against colleagues or higher authorities;
9. Faculty should participate in programmes of professional growth like in-service education and training, seminars, symposia workshops, conferences, self study etc; .
10. Faculty should avoid conflict between their professional work and private interests which could reasonably be deemed to impact negatively on pupils/students.

11. Recognize the management as the prime source of his sustainable development; and develop mutual respect and trust through his professional activities and outputs.


Code of Ethics and Conduct for the Support Staff:

Discipline and Code of Conduct

Discipline :-

1. Students are prohibited from doing anything in side or out side the college that will interfere with its orderly administration or its public image.
2. Students restoring to unfair means at the exmination will be dealt with in accordance with the provision of the Government of Maharashtra Act No. XXXI of 1982 and the Maharashtra Universities act, 1994.
3. All students are expected to observe rules and regulations currently in force to enable the smooth working of the college.
4. Ragging is crime & is a punishable affence.

Code of Conduct :-

Once a student is admitted in the college, he/she must abide by the following rules and regulations.

1. Students must have identity card with them in the campus and produce it on demand.
2. Students must go through various notices and circulars displayed on notice boards of the college or laboratories from time to time regarding all activities including examinations, scholarship, placement opportunities, functions etc. The college will not be responsible for any loss of the students regarding events and facilities mentioned above.
3. It is compulsory to attend popular lectures/seminars/debates/fuctions arranged by the college.
4. Minimum 80% attendance in a regular theory and practical classes is compulsory for grant of term. Otherwise they will not be allowed to appear for examination and get the benefit of the scholarship.
5. Home assignments, tests, tutorials, seminars are compulsory.
6. Fines are imposed for the absense to classes & various activities without prior information.
7. Students are expected to take active part in extra-curricular activities orgnized by the college from time to time.
8. Students must park their vehicles in the parking stand only.
9. Students must keep campus clean by placing their waste in dustbins and containers.
10. Students should maintain healthy and friendly climate with classmates or college mates.
11. Without prior permission of Principal, students cannot display their wall papers, articles etc. on the notice board.
12. Suggestion in writing may be welcomed or use suggestions box.
